**Breeding Contract for**

This certifies \_\_\_\_\_ has contracted to serve the mare stated above with semen from *LCI Nitro* for the 2011 breeding season.

This agreement is subject to the following terms and conditions:

1. The breeding fee will be \$500 per mare. The breeding fee must be paid and this contract signed and returned, along with a copy of the mare's registration papers prior to the shipping of semen or arrival of the mare if breeding on farm.
2. The contract service fee includes breeding privileges for 2011 and for return privilege in 2012 if a licensed veterinarian notifies Belgian Hill Farm in writing by September 1, 2011 of the above mare being open.
3. We offer fresh chilled semen by next day UPS or on farm artificial insemination.
4. Breeding season runs from February 1<sup>st</sup> thru July 1<sup>st</sup>. Semen will be shipped on weekdays only. Saturday and Sunday shipments are not available.
5. Contact us the first day of heat for your mare so we can get an idea when you will need semen and then call again to actually order the semen on collection day. We encourage you to call before 10:00 AM CST on collection days to ensure you will receive semen. We cannot guarantee available semen after this time.
6. The mare owner will pay all shipping charges plus a \$25.00 lab and collection fee per shipment of semen. All shipping, lab and collection fees will be billed to the mare owner and payment is due upon receipt.
7. All shipping containers must be returned within two days of arrival. Late containers will be charged \$25.00 per day and there will be no more shipments made until it is returned or paid for at a cost of \$300.00.
8. We are not responsible for lost, delayed, or damaged semen during shipping.
9. For on farm service the mare owner agrees to pay any veterinary costs associated with breeding or caring for your mare.
10. For on farm day care of your mare we charge the following fees:
  - a. Box Stall \$12.00 per day
  - b. Box stall w/foal \$14.00 per day
  - c. Dry lot outside \$ 9.00 per day
11. If *LCI Nitro* dies or is no longer in the possession of Belgian Hill Farm or otherwise becomes unfit for service before the first delivery of semen then this contract terminates automatically upon notice received by the other party without liability and all prepaid fees shall be refunded

to the mare owner in full. If any of these events occur to *LCI Nitro* after the first delivery of semen and the mare is not impregnated as a result, then the mare owner may either substitute another stallion at Belgian Hill Farm to fulfill the terms of this contract or forfeit all moneys paid.

12. If the mare contracted above dies, becomes unfit for breeding, or is sold prior to first shipment of semen then the owner stated above can substitute another mare to fulfill the contract. If no substitute is made all moneys paid are forfeited.
13. Registration of the foal resulting from this contract is the responsibility of the mare owner. A signed breeder's certificate will be furnished when the mare is confirmed pregnant by a veterinarian and all applicable expenses and fees have been paid in full.
14. Belgian Hill Farm, its agents, partners, and its employees shall not be liable for injury, death, infection, or other disability suffered by the mare from any cause whatsoever, and the owner assents to such conditions and waives each and every claim for damages resulting from any such injury, death, infection, or other disability. Neither party is responsible for any liabilities arising from inability to perform this contract as a result of acts of God or other acts beyond either party's control.
15. The mare owner understands and agrees to comply with all the requirements of the Belgian Draft Horse Corp. of America in regards to receiving and using transported semen and AI.
